Nicole's coaching days are Mondays to Thursdays from 8:30 am to 4:30 pm Pacific. In some cases she can take clients on Saturdays, but she does not coach evenings.

Cancellations will come up from time to time and rescheduling may be necessary for both parties. Nicole requests a 24-hour (one business day) cancellation. If appointments can be rescheduled, they absolutely will be, however, if Nicole does not have open availability and it is the client that must cancel within less than 24-hours notice, that session may be lost. Please note that this is a rare occurrence.
